ActivTab<sup>™</sup>(LS) Tablets diffuse invisible, odorless, and non-toxic ZERUST<sup>®</sup> Vapor Corrosion Inhibitor (VCI) technology that settles onto exposed metal surfaces inside the enclosure. Upon removal, the VCI will dissipate from the metal surfaces, allowing immediate use or further processing. ActivTab<sup>™</sup>(LS) VCI Tablets work fast to protect ferrous metals and aluminum against flash corrosion and continue to protect for up to 6 months<sup>‡</sup> in a sealed enclosure. Additionally, ActivTab<sup>™</sup>(LS) protects yellow metals such as copper and brass when used as instructed. However, do not place in direct contact, and test before use.

## **Operating Summary**

- Remove the product from the packaging.
- Take note of the installation date. ActivTab<sup>™</sup>(LS) Tablets are to provide up to 6 months<sup>+</sup> of protection (See Protection Info on page 2 for specific protection capabilities).
- Place the ActivTab<sup>™</sup>(LS) Tablet in the most ideal location possible following the principles below:
  - Center: The ideal location to obtain maximum coverage of protection from the tablet. This position may not be possible if the center is occupied.
    - Corner: In deeper enclosures, two tablets may be required on diagonally opposed corners to fully protect the entire space.
  - Sides: This is practical for most applications and provides the optimum side-mounted protection.
  - Dual Placement: For longer boxes or divided spaces, place a tablet in opposite corners for complete coverage.
- Ensure that the airflow to the enclosure is restricted. It is essential to restrict airflow to the container, as airflow removes the protective vapor barrier from the space faster than it can be released from the ActivTab<sup>™</sup>(LS) Tablet.
  - When applying ActivTab<sup>™</sup>(LS) Tablets within enclosures where the air is replaced regularly, such as air-cooling systems, it is recommended to place the tablets close to the source of airflow. For added corrosion protection, consider placing an additional ActivTab<sup>™</sup> (LS) Tablets near the sensitive metal surface to be protected.
- Upon removal of the ActivTab<sup>™</sup> (LS) Tablet or opening the enclosure, the ZERUST<sup>®</sup> protective molecules will dissipate from the metal surface in a few hours. Corrosion protection of the metal surface will also cease by this time.

#### Storage

- Store in a cool, dry place and away from sunlight in the original packaging.
- Optimal storage temperature is < 85°F (29°C) and 50% RH for up to 2 years from the date of shipment.
- Reseal the bottle after use. Products exposed to the environment over prolonged periods of time may become less effective.
